ILCA Class Rules, the Sailing Instructions. USCGA Life-vest must be worn.

ELIGIBILITY: Laser and Laser Radials are welcome to compete; however there will be no separate Laser

radial starts or scoring. Laser Class membership is encouraged but not required.

MEASUREMENT: All equipment shall conform to class rules.

ADVERTISING: No advertising will be displayed. As defined by ISAF Regulation 20, advertising is a name, logo, slogan, description, depiction, a variation or distortion thereof, or any other form of communication that promotes an organization, person, product, service, brand or idea so as to call attention to it or to persuade persons or organizations to buy, approve or otherwise support it.

QUALIFYING SERIES AND FINAL SERIES: One completed race will constitute a regatta.

SAILING INSTRUCTIONS: The sailing instructions will be available at Registration.

THE COURSES: The courses to be sailed shall be modified windward/leeward with the start/finish located between

the windward and leeward marks. Marks are to be rounded to port. The course will be displayed on the committee boat course board and designated as "W" followed by a number, if other than 1, that

designates the number of downwind legs.

PROTESTS: Protests will be assessed by a modified three minute hearing. However, competitors are expected to be courteous and mindful of the rules and encouraged to resolve their issues by doing their turns.

PENALTY SYSTEM: Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.
